4. Entries must be received by Thursday 28 February 2019. Entries received after this date will not be accepted.
5. Our prize draws and competitions are free to enter and no purchase is necessary.

Royal Armouries will not accept responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.

Eligibility

The Draw

16. The prize will be sent to the winner within 14 days of responding to Royal Armouries.
